The Southern Alleghenies ECE Shared Services Alliance (https://thelearninglamp.org/shared-services-child-care-providers/) is a group of 37 early learning providers in the region who benefit from

- Free staff recruitment
- Co-op students
- Substitute staffing pool
- Human resource guidance
- Early childhood apprenticeship

The Learning Lamp is working to improve childcare service availability in the region by expanding a childcare center in Somerset as well as working with Laurel Valley School District for onsite child care micro center.
